1 Preamble, Processing Personal Data

The BEV - Bundesamt für Eich- und Vermessungswesen only uses the access rights needed for the functionalities of the "Austrian Map mobile" (AMap mobile) app.

The BEV neither collects, processes, stores or passes to third parties personal information nor has the BEV access to personal data of any kind.

Data protection is very important to the BEV and is observed in accordance with the General Data Protection Regulation (GDPR) as well as the Austrian Datenschutzgesetz.

The latest version of the Apple Privacy Policy has to be taken into account (<https://www.apple.com/de/privacy/>).

2 Necessary Authorizations

For the operation of the app it is necessary to have access to those rights which are indicated for the installation of the app. You can find those in the app store respectively the app administration of the respective mobile device. These access rights are explained below. The BEV – as mentioned at the beginning – has no access to the below listed areas.

2.1 Position Determination

For localization, recording of a track respectively the navigation function it is necessary to access the positioning level, actively as well as in the background (track logs). But this is only necessary for direct use; the user behaviour is not recorded or stored.

2.2 Network Connections

To download map tiles, height data and to import or export Tracks/POIs you need access to a network (mobile network or WLAN).

2.3 Storage

All data (map tiles, height data, tracks, POIs, local storage) are stored locally on the device, thus it is necessary to access the storage system.

2.4 Sleep Mode

For downloads of areas it is necessary to deactivate the sleep mode due to the duration of the download. After the download is completed the sleep mode will be activated automatically.

2.5 Telephone / Identity and In-app Purchases

For in-app purchases (areas or tile packages) and for local backup it is necessary to access the levels phone status and identity. The BEV does not read out, process or store personal data e.g. contacts. Orders within the app (i.e. orders of tile packages or areas) are processed by the app store not by the BEV. The BEV has no influence whatever on this transaction between the user and Apple and the terms of business of Apple.

2.6 Camera

To use the function "Augmented Reality" it is necessary to have access to the camera of the respective device.

3 Restriction of Access Rights, Deinstallation

In case of a contradiction concerning the access rights the app can not be used as provided for and thus will not be installed. If the app is deinstalled all relevant data will be deleted.
